2. Every effort will be made to meet requested booth locations, subject to availability. With This Ring...Bridal Gala reserves the right to determine the final placement of any exhibitor in the show regardless of location requests.
3. With This Ring...Bridal Gala agrees to provide the Exhibitor with a standard booth and side railings as required and provided prior to the move-in of the show.
4. Signed contracts along with full payment are due no later than 30 days prior to the show.
5. Only registered exhibitors are allowed to promote their products and services at this show. Outside and/or non-registered products and businesses are not permitted to be displayed, distributed, or marketed in any way in the show.
6. With This Ring...Bridal Gala does not provide exhibitors with exclusivity to any one particular product or service unless specifically negotiated in writing through sponsorship.
7. With This Ring...Bridal Gala reserves the right at any time to alter or remove exhibitors or any part thereof, including printed materials, product, signs, lights or sound, and to expel Exhibitors or their personnel if, in With This Ring...Bridal Gala's opinion, their conduct or presentation is objectionable to other Show participants.
8. The exhibitor agrees to hold harmless With This Ring...Bridal Gala, its agents, servants, staff, students, volunteers and sponsors, from and against any or all loss claims including accidents, damage, injury or death regardless of action in relation to the activities arising from the production and promotion of the With This Ring...Bridal Gala.
